RESIGNATION OF AN INDEPENDENT NON-EXECUTIVE DIRECTOR, MEMBER OF AUDIT COMMITTEE AND MEMBER OF REMUNERATION COMMITTEE

The board of directors (the “Board”) of Chinainfo Holdings Limited (the “Company”) hereby announces that Mr. Chiu Kwok Ching (“Mr. Chiu”) resigned as the Independent Non-Executive Director of the Company with effect from 27 November 2006 due to personal reasons. Mr. Chiu also resigned as the member of audit committee and remuneration committee of the Company with effect from the same date. Mr. Chiu confirmed that he has no disagreement with the Board and there is no matter relating to his resignation that needs to be brought to the attention of the shareholders of the Company. The Board would like to take this opportunity to express its appreciation for the valuable contribution of Mr. Chiu towards the Company during his years of service to the Company.

After Mr. Chiu’s resignation, the number of independent non-executive director of the Company falls below the minimum requirement pursuant to Rule 5.05 of the Rules of Governing the Listing of Securities on the Growth Enterprise Market of The Stock Exchange of Hong Kong Limited (the “GEM Listing Rules”). As such, the Board will make its best endeavours to identify an appropriate person to fill the vacancies for the positions of independent non-executive director, member of the audit committee and member of remuneration committee of the Company within three months from the date of Mr. Chiu’s resignation. Further announcement will be made by the Company upon fulfilling the requirement under Rule 5.06 of the GEM Listing Rules.
