CHANGE OF COMPANY NAME

The Board is pleased to announce that the Certificate of Incorporation on Change of Name was issued by the Registry of Companies in the Cayman Islands on 26 March 2010 certifying that the change of name of the Company from “China Cyber Port (International) Company Limited” to “China Communication Telecom Services Company Limited” has been registered and the new Chinese name “神通電信服務有限公司” has been adopted by the Company to replace “神州奧美網絡(國際)有限公司” which was previously adopted for identification purpose. The Certificate of Registration of Change of Name of non-Hong Kong Company was issued by the Registrar of Companies in Hong Kong on 26 April 2010 confirming the registration of the new English name “China Communication Telecom Services Company Limited” and the new Chinese name “神通電信服務有限公司” in Hong Kong under Part XI of Companies Ordinance.

CHANGE OF STOCK SHORT NAME

The Shares will be traded on the Stock Exchange under the new stock short name of “C COMM TELE SER” in English and “神通電信服務” in Chinese with effect from 9:30 a.m. on 10 May 2010. The stock code of the Company remains as 8206.

EFFECT OF THE CHANGE OF COMPANY NAME

The change of the name of the Company will not affect any right of the Shareholders. All existing share certificates of the Company shall continue to be evidence of title to the Shares and valid for trading settlement, delivery and registration purposes. There will not be any arrangement for exchange of the existing share certificates.

Reference is made to the circular (the “**Circular**”) of China Communication Telecom Services Company Limited 神通電信服務有限公司 (formerly known as China Cyber Port (International) Company Limited) (the “**Company**”) dated 5 February 2010 and the announcement of the Company dated 15 January 2010 in relation to, among other things, the proposed change of the Company’s name. Capitalized terms used herein shall have the same meanings as those defined in the Circular unless otherwise stated.

CHANGE OF COMPANY NAME

Pursuant to the approval by the Shareholders at the EGM on 11 March 2010, the Board is pleased to announce that the Certificate of Incorporation on Change of Name was issued by the Registry of Companies in the Cayman Islands on 26 March 2010 certifying that the change of name of the Company from “China Cyber Port (International) Company Limited” to “China Communication Telecom Services Company Limited” has been registered and the new Chinese name “神通電信服務有限公司” has been adopted by the Company to replace “神州奧美網絡(國際)有限公司” which was previously adopted for identification purpose. Further, the Certificate of Registration of Change of Corporate Name of Non-Hong Kong Company was issued by the Registrar of Companies in Hong Kong on 26 April 2010 confirming the registration of the new English name “China Communication Telecom Services Company Limited” and the new Chinese name “神通電信服務有限公司” in Hong Kong under Part XI of Companies Ordinance. Since all the conditions for the name change have been met, the name of the Company has been changed from “China Cyber Port (International) Company Limited” to “China Communication Telecom Services Company Limited” and the new Chinese name “神通電信服務有限公司” shall be adopted by the Company.

CHANGE OF STOCK SHORT NAME

Following the change of Company’s name becoming effective, the Shares will be traded on the Stock Exchange under the new stock short name of “C COMM TELE SER” in English and “神通電信服務” in Chinese, instead of “China Cyber Port” and “神州奧美網絡”, with effect from 9:30 a.m. on 10 May 2010. The stock code of the Company remains as 8206.

EFFECT OF THE CHANGE OF COMPANY NAME

The change of the name of the Company will not affect any right of the Shareholders or the Company’s daily business operation and its financial position. All existing share certificates bearing the existing name of “China Cyber Port (International) Company Limited” or “Chinainfo Holdings Limited” or “HK6 Holdings Limited” shall continue to be evidence of title to the Shares and valid for trading settlement, delivery and registration purposes. There will not be any arrangement for exchange of the existing share certificates. New Share certificates will be issued under the new name of the Company.
